This series contains the various records administered by the clerks of the Senate and House of Representatives in their function to support the daily deliberative and law-making activities of the Territorial legislature. These records are the primary materials from which the official journals were compiled. Much of the material in this series is included in its entirety in the official journal, a notable exception being the bills, which are not verbatim in the journals. Issues addressed by the Territorial Legislature include Hawaiian statehood, public works projects, public instruction concerns, business regulation, post-war planning, and a few investigations of alleged malfeasance and incompetence. There is some Hawaiian language material in the early years.

Arranged chronologically by session, there under by chamber with the Senate followed by the House of Representatives, there under by type of record in the following order: journals; bills; joint resolutions; concurrent resolutions; resolutions; holdover committee reports; joint committee reports, conference committee reports; special committee reports; committee of the whole reports; standing committee reports; petitions; Governor's messages; executive communications; communications from the other chamber; departmental communications; miscellaneous communications; orders; questions; answers; notices; miscellaneous; and bills, joint resolutions, and concurrent resolutions received from the other chamber but not acted upon; and there under in numerical order of applicable.

Related records include Series 227, Official Journals; Series 229, Records of the Standing and Special Committees; Series 230 Records of Holdover Committees; and Series 233, Financial Records of the Legislature of the Territory of Hawaii. Additional legislative records are Series 222, General Records of the Legislature of the Hawaiian Kingdom; and Series 226, General Records of the Legislature of the Republic of Hawaii.

There are no restrictions on access to these records.
